ATAYEV v. Russia

Dear Sir,

With reference to your letter of 19 August 2008 in respect of the above application, whereby the Russian Federation authorities are invited to submit the requested information, the Russian Federation authorities inform the Court of the following.

On 5 August 2008 the Oktyabrskiy District Court of Krasnodar delivered grant of parole in respect of the applicant. At that the applicant was not released.

In this connection the Russian Federation authorities inform the Court that at present they are taking relevant measures to clarify the



situation and remedy the applicant rights violated, if it's the case. At that taking into account the insufficient time-limit the Russian Federation authorities note that the Court will be informed of the results of the measures taken.

Then, the Russian Federation authorities inform the Court that under the results of the medical examinations of 20, 21 and 22 August 2008 the applicant's state of health is satisfactory and no medical assistance is required.

On 23 August 2008 the applicant submitted the statement on termination of his hunger strike.
